Directors' Report.

The Directors herewith submit to the Shareholders of the Company a Balance Sheet for the past year, ending August 31st, 1912.

The Books of the Company have been audited and all vouchers examined by Mr. J. E. Dutton, and the Balance Sheet duly signed by him.

The Revenue Account, with the Balance brought forward, shows a net profit of £31 0s. 3d. on the year. The Directors, therefore, recommend that no Dividend be paid this year, but carry forward the amount to the present year.

The reduction in the Revenue Account has been brought about by the amount, £75, refunded for the time being to the Football Club (sanctioned at the Special General Meeting of Shareholders, held on June 7th last) to help the Club over the financial loss sustained last season. **This amount is practically equal to 2**½ **per cent. on the Share Capital.**

The Directors have nominated Mr. F. W. Lovesy to represent the Company on the Finance Committee of the Football Club, and he has kindly consented to act.

In accordance with the Articles of Association, three of the Directors, Messrs. F. H. Bretherton, C. H. Dancey and Harry A. Dancey retire, and being eligible offer themselves for re-election.

Mr. J. E. Dutton, Auditor, also retires and offers himself for re-election.

The Directors are pleased to again report that the ground is in good condition.

GLOUCESTER FOOTBALL AND ATHLETIC GROUND CO., LTD.

The annual general meeting of shareholders was held at the New Inn Hotel, Gloucester, on Thursday evening, Mr. A. W. Vears (Chairman of Directors) presiding over a small attendance.

In moving the adoption of the report and balance sheet (which has already been published in the "Citizen"), the Chairman regretted the Directors were unable to recommend the payment of a dividend this year, but it was obvious to all of them the reason they could not do so. The Football Club had a disastrous time last season, and the Company were called upon to make an allowance in the rent - a temporary one - which would have been sufficient to pay a $2\frac{1}{2}$ per cent. dividend. He should like to emphasise the point that this allowance was only a temporary one, because several shareholders and some of the public had got the impression that the Company had made a permanent reduction of £75 a year in the rent of the ground to the Football Club. That was not so; the allowance was only made for the time being, and when the funds of the Club allowed, it would be refunded to the Company. Mr. C. E. Brown seconded the Chairman's resolution, and it was carried.

On the proposition of Mr. W. J. Robinson, seconded by Mr. C. Granville Clutterbuck, the retiring Directors (Messrs. F. H. Bretherton, C. H. Dancey, and Harry A. Dancey) were reelected; as was also Mr. J. E. Dutton as auditor, on the motion of Mr. C. H. Dancey, seconded by Mr. Robinson.

A vote of thanks to the Chairman and Directors concluded the proceedings.
